GOLD PROSPECTORS TERMS AND DEFINITIONS

So far the feedback from last month's first edition of "Gold Prospectors Terms and Definitions" has been positive. Several SWWGP members indicated that pictures would also help understand some technical terms and or specialized equipment. - A **Gold Pan** is a circular concave device used to separate gold and black sand from lighter materials. Originally gold pans were made of steel but today the vast majority of the gold pans are made from hard plastic. Gold pans are available in a variety of colors and shapes with different riffle patterns.
- **Gold panning**, is a method of placer (plac-er) mining and was the traditional method for extracting gold from a placer deposit. "Panning" is one of the simplest ways to extract gold, and is popular with new prospectors especially because of its cheap cost and the relatively simple and easy process. Once a suitable placer deposit is located, gravel is scooped into a pan where it is then gently agitated in water and the gold sinks to the bottom of the pan. Materials with a low specific gravity are allowed to spill out of the pan, whereas materials with a high specific gravity sink to the bottom of the sediment during agitation and remain within the pan for examination and collection by the gold panner. These dense materials usually consist primarily of a black, magnetite sand with whatever gemstones or metal dust that may be found in the deposit that is used for source material. In many situations, gold panning usually turns up only minor gold dust that is usually collected as a souvenir in small clear tubes. Nuggets and considerable amounts of dust are occasionally found, but panning mining is not generally lucrative. Panning for gold can be used to locate the parent gold veins which are the source of most placer deposits.



- **Classifiers** - A good classifier (or even a whole set) is essential for today's gold prospector. An inexpensive classifier, or a set of classifiers is a great tool for the beginning panner. Classifiers are made of stainless steel and plastic with multiple mesh size options (2, 4, 8, 12, 20, 30, 50, 70 and 100). A screen, sieve or classifier is used to reduce rock, gravel and sand to a manageable size—one that is close to the size of the gold you expect to recover. Most classifiers are designed to fit over a 14" gold pan or five gallon bucket. Large nuggets are very rare so most gold is very fine with an occasional "picker" nugget. It is best to begin with a quarter-inch (#4 mesh) screen. While gold is heavy fine gold flakes will have a hard time displacing large rocks. Screening or classifying materials using multiple classifiers (progressively smaller mesh) will make it easier to recover fine gold which is the type usually found in Washington streams. The screened off rock and gravel should also be panned separately to wash off any gold particles and to search for "nuggets" or gold imbedded in rocks.



- **Hand Tools** - Panning for gold requires digging, classifying and panning large amounts of alluvial rocks, gravel and sand. The beginning gold prospector can accomplish this using only their hands but having an assortment of hand tools will significantly increase the speed and ease of panning for gold. The primary tool is some type of digging implement; i.e., small shovel, folding shovel, trowel, scoop, pry bar, crevice tool, screw driver, etc. These hand tools make it possible to get down to "bedrock" or "hard-pan" which are the levels at which fine gold collects. Other hand tools which are useful when panning for gold (not dredging) are a small stiff brush and a small "dust" pan to sweep the bed rock or hard pan for the finest back sand and gold. In certain locations the use of water with a spray bottle and a "turkey baster" to suck-up the mud may prove helpful. Assuming most SWWGP Club members are seeking alluvial, not lode gold, we will skip the hard rock hand tools for the time being.





CODE OF ETHICS

1. I will respect private property and will refrain from treasure hunting without the property owner(s)' permission.
2. I will fill my treasure hunting excavations and prospecting holes in good faith.
3. I will use thoughtfulness, consideration and courtesy at all times.
4. I will properly dispose of trash that I find and will not litter.
5. I will leave gates as I found them.
6. I will honor the rules and regulations of the BLM and Forestry Service at all times and will respect all laws and ordinances set forth to govern prospecting and mining.
7. I will not destroy private property, buildings, or what remains of ghost towns and deserted historical structures.
8. I will not tamper with signs, structural facilities, and/or equipment.
9. I will respect other prospectors' claims and will not work those claims without granted permission from the claim owner(s).
10. I will appreciate and protect our heritage of natural resources, wildlife and fisheries.
11. I will only build fires in designated areas and will do so in accordance with the current federal, state and local guidelines.
12. I will use extreme caution when handling fuels and motor oils taking into consideration their potential destructive effects on the environment.
13. I will have all necessary permits and licenses on hand in accordance with GPAA rules and regulations in conjunction with Local, State and Federal prospecting laws.
14. I will not remove stream bank material, destroy natural vegetation or woody debris dams, nor discharge excess silt into waterways under any circumstances.
15. I will not refuel motorized equipment in or near streams preventing oil from motorized equipment to penetrate the water and/or surrounding areas.
16. I will not prospect in areas void to mining.
17. I will be respectful and considerate when in the presence of minors.

MISSION

The mission of the Gold Prospectors Association of America is to further the advancement of gold prospecting and treasure hunting by:

1. Developing an organization that actively encourages camaraderie, fellowship and personal contact amongst people who share a mutual interest in gold prospecting.
2. Adhering to environmental laws, rules and regulations.
3. Following the Bureau of Land Management, Forest Service and Army Corps of Engineers laws and doctrines to ensure a positive representation of prospecting in our industry.
4. Promoting public awareness of ecologically sound prospecting and small-scale recreational mining for adults, families and children.
5. Teaching club/chapter members how to successfully prospect for gold and treasures.
6. Developing teachers and/or mentors who are passionate about the education of prospecting.
7. Educating the general public nationwide about the history and future of gold prospecting and the importance of mineral extraction.

SWWGP Article Three—Purpose

Historic regions like the Liberty region in Kittitas County, the Peshastin area in Chelan County, the region south of and close-by Republic in Ferry County, the Okanogan Highlands and Western Okanogan in Okanogan County and the Sullivan Creek district in Pend Oreille County are probably the best bets in the six counties. The chances of discovering a virgin placer gold creek are slim indeed. The best gold creeks have already been found so stay in the old regions.



1880'S GOLD MINING DISPLAY AT THE HIGH DESERT MUSEUM - BEND, OREGON



The display starts with a stroll past a Northern Paiute shelter and a French trapper's camp where all the historic details are depicted in incredible detail. Continues through the Hudson's Bay Company fort, alongside an Oregon Trail wagon, through a hard rock mine, past a settler's cabin and into the boomtown of Silver City.
